On 02/08/2023 at approximately 21:50 hours, I, Officer Hepler was dispatched to 7(1)(b): Private for a physical fight. MetCom advised the caller was being threatened to fight. The caller reported she was hit. The caller was heard screaming and arguing in the background with 7(1)(c): . Officer Briggs and Officer Armstrong responded as well.

For clarity and brevity I have paraphrased and summarized the following incident. The items discussed may or may not be written in the order they appear on my Body Worn Camera. The words I have chosen for this report may not be the exact words used by the involved parties. At this time, I have not watched my Body Worn Camera footage.

Upon my arrival, I vaguely heard arguing coming from inside the residence but I could not make out what was being said. I made contact with 7(1)(c): Third party who let me into the residence. 7(1)(c): stated 7(1)(c) and 7(1)(d)(iv) - Statements provided by third parties . I made contact with 7(1)(c) and 7(1)(c) at the top of the staircase. 7(1)(c) and 7(1)(d)(iv) - Statements provided by third parties . 7(1)(c) was crying and 7(1)(c): Statements from Victims . 7(1)(c) walked into a bedroom, later identified as 7(1)(c): bedroom, and picked up a knife from next to the bed. 7(1)(c) attempted to take a step toward the bedroom to follow 7(1)(c) . I grabbed 7(1)(c): arm to stop her movement because I did not want her near 7(1)(c) while she possessed the knife. I told 7(1)(c) to put the knife down. 7(1)(c) placed the knife next to the bed and walked out of the room. 7(1)(c) was not holding the knife in a threatening position. 7(1)(c) picked up the knife to show me its location. I asked 7(1)(c) to go downstairs and wait with 7(1)(c): for additional Officers to arrive. Officer Briggs and Officer Armstrong arrived on scene and spoke with 7(1)(c): and 7(1)(c) . Please refer to Officer Brigg's supplemental report for their statements.

7(1)(c) was distraught and 7(1)(c): Statements from . 7(1)(c) called 7(1)(c): and placed the call on speaker phone. 7(1)(c) told 7(1)(c) what happened and she picked up a knife sometime during the incident. 7(1)(c): Third informed 7(1)(c) that was not an acceptable action. 7(1)(c): Third encouraged 7(1)(c) to tell Officers the truth about what happened during tonight's incident. Once 7(1)(c) completed her conversation with 7(1)(c): , I asked 7(1)(c) to tell me what happened.
